

De uitsluiting van Rheinmetall AG was nieuw per 1 oktober 2023 en werd in eerste instantie tot 31 december 2023 getolereerd vanwege de omvang van deze belegging. Op basis van het <u>publieke voornemen van Rheinmetall om de productie van witte fosfor houdende ammunitie uiterlijk midden 2024 te beëindigen</u>, mag Rheinmetall tot 30 juni 2024 in portefeuille blijven.

The Rheinmetall AG exclusion was new as of Q4 2023. Due to the size of this investment, a grace period was provided for this holding until 31 December 2023. Based on Rheinmetall's publicly announced plans to terminate the production of ammunition containing white phosphorus by mid-2024, this grace period has been extended by six months.
